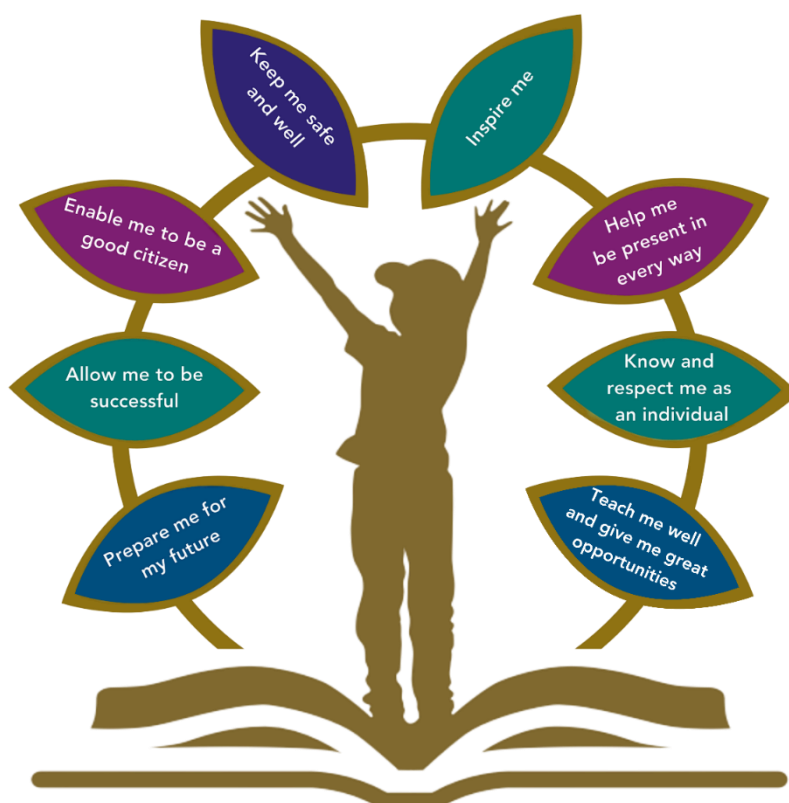

3. Introduction

4. My Safe Technology Promises

✓ I will use technology for learning	I will use school devices, websites, apps and accounts in the way my teacher asks.
✓ I will be kind	I will use friendly and respectful words. I will not send or share anything that could hurt, frighten or embarrass someone.
✓ I will keep personal information private	I will not share my full name, address, phone number, password, location or photographs unless a trusted adult says it is safe.
✓ I will keep passwords safe	I will use only my own account. I will not share my password or try to use another person's account.
✓ I will ask before taking or sharing pictures	I will only take, record or share photographs, videos or sound when a teacher gives permission.
✓ I will stay on approved websites and apps	I will not download, install or buy anything, or click adverts and pop-ups, without permission.
✓ I will tell an adult if something goes wrong	If I see something unsafe, unkind or unsuitable, I will stop, leave it on the screen if safe to do so, and tell a trusted adult straight away.
✓ I will look after equipment	I will carry devices carefully, keep food and drink away, and report damage or problems.
✓ I will not try to get around safety controls	I will not change settings or try to bypass the school's filtering, monitoring or security.
✓ I will use AI only when my teacher allows it	I will ask before using an AI tool. I will not tell it private information, and I will check its answers with my teacher.
✓ I will follow the school's rules for phones and smart devices	I will keep personal phones, watches and similar devices stored or switched off as my school requires.

5. What the school will do

- The school uses filtering to help block harmful or unsuitable content.
- The school will monitor activity on its devices, networks and accounts to help keep people and systems safe.
- A member of staff may check activity if there is a safeguarding, security or behaviour concern.
- The school may limit or remove access if these rules are not followed. Any response will follow the school's behaviour and safeguarding procedures.
